

Arbor Day and Autumn Tree Planting Program

1999 – 2019

- 1999** – Creation of a tree replacement program.
- 2000** – Removal of trees on Market Street, outside cemetery wall.
Planted 11 European Hornbeam on east side of gatehouse on Market Street.
- 2001** - Planted 13 European Hornbeam on west side of gatehouse on Market Street.
- 2002** - Planted 6 Pin Oaks on east side of gatehouse on inside of wall.
- 2003** - Planted 4 Pin Oaks on east side of gatehouse on inside of wall.
Planted 3 'Red Sunset' Red Maples -one on each side of 16th Street entrance and one at corner of Section 5 at junction of Mt. Laurel Ave. and Valley Road.
Planted 1 Green Leaf Weeping Japanese Maple on family plot VV, Lot #7.
Planted 1 Littleleaf Linden tree in Section 5, on opposite corner of #9 on Valley Road
- 2004** - Trees removed around loop of Mt. Laurel Avenue.
Planted 3 London Plane west of gatehouse on inside wall.
Planted 5 'Red Sunset' Red Maple on Woodland Ave. loop between Trinity and Mt. Laurel.
- 2005** - Remove trees on Mt. Laurel Ave. closer to carriage house.
Planted 7 'Red Sunset' Red Maples on Mt. Laurel Ave. close to carriage house road. Replaced 2 European Hornbeam on Market Street.
Planted 3 Pin Oak on Trinity Ave. downside of road across from London Planetree.
Planted 1 Japanese Red Maple on east side of gatehouse.
Fall - Planted 1 Japanese Lilac on west side of carriage house.
- 2006** - Removed 6 trees on Mt. Laurel Ave coming up hill.
Planted 10 'Red Sunset' Red Maples (5 on each side) on Mt. Laurel Ave. starting up hill.
Planted 1 Norway Spruce on hill facing small gate on east side by 13th Street.
Planted 1 Japanese Maple west side of carriage house.
Fall - Planted 1 Sweet Gum at corner of Valley Rd. and east loop of Maplewood Ave.
Planting was from excess of city plantings.
- 2007** - Planted 13 'Red Sunset' Red Maple on Mt. Laurel Ave. hill closer to chapel.
Planted 1 Flowering Dogwood near south side of Atkin's mausoleum off Mt. Laurel Ave.
Fall - Planted 1 Sweet Gum at corner of Valley Rd. and north Oak Rd. Planting was from

excess of city plantings.

- 2008** - Planted 5 Sweet Gum in lower section, 4 along Valley Road across from each other, 1 on east loop of Maplewood Ave. up from 2006 Sweet Gum planting.
Planted 5 Dawn Redwood in lower section on Oak Ave. between Elm Ave and Valley Rd.
9\08 - Planted 1 Flowering Dogwood at the mediation area by the pond.
Fall - Planted 1 Callery Pear east of the Carriage House.
- 2009** - Planted 5 Dawn Redwood in lower section on Oak Ave. between Elm Ave and Valley Rd.
Planted 5 Sugar Maple in lower section - 3 on grass lane known as White Rose\Azalea and 2 on northern part of east loop of Maplewood Av. between 2 mature Sugar Maples. .
9\09 - Planted 16 Eastern Redcedar along fence of McBarron St. and behind 16th St. homes.
Fall - Planted 1 Callery Pear by the bench off Elm Avenue.
- 2010** - Planted 7 'Homestead' Hybrid Elm- 5 in an "L" shape with 3 on Valley Rd. and 2 on East Lake Rd. Two were planted on Elm Ave. before it meets Oak Road. Nos. 76, 77, 79, 82, 83, 84, and 85.
Planted 1 Sweet Gum at east corner of Oak Ave. before it meets Valley Road.
Planted 1 Sugar Maple at corner of east Lake Road and Elm Avenue.
Planted 1 Pin Oak on Elm Avenue across from the pond.
Fall - Transplanted 1 Callery Pear from somewhere in Pottsville to east side of carriage house.
- 2011** - Planted 6 Swamp White Oak on West Lake Road. Nos. 88, 89, 90, 91, 92, and 94.
Planted 2 'Homestead' Hybrid Elm - one at corner of East Lake Rd. and Elm Ave. and 1 on south side of Elm Ave after east Lake Rd. interception. Nos. 93 and 94.
Planted 1 Sunset Red Maple near Mt. Laurel Ave. across from West Lake Road interception. No. 97.
Planted 1 Pin Oak inside the 16th St. gate at corner of Valley Road and Woodland Avenue. No. 78.
- 2012** - Planted 6 Eastern White Pine across from each other and along eastern side of Mt. Laurel toward where 13th Street would intersect property. Nos.98, 99, 100, 101, and 105.
Planted 1 Littleleaf Linden at corner of Mt. Laurel at Sec. 6 near where a mature one toppled in the Summer of 2011.
Planted 1 'Red Sunset' Red Maple near Mt. Laurel Ave. in Sec. 5 where the 2011 snowfall cracked the other 'Red Sunset' Red Maple tree.
Planted 1 Pin Oak inside and south of the 16th St. gate by 1st neighbor's house. No. 106
Planted 1 Flowering Dogwood inside & south of 16th St. gate between 1st and 2nd neighbor's house. No.107.
- 2013** - Planted 10 'Red Sunset' Red Maple on northern side of Chapel Ave. and along grass path off of Chapel.Ave. that separates two Mt. Laurel Cemetery (1845) sections owned by

Trinity Church east of the chapel. Nos. 109, 110, 111, 112, 113, 114, 115, 116, 117, and 118.

Planted 1 Flowering Dogwood on south side of Mt. Laurel Avenue between section A and B. No. 108

2014 - Planted 6 Black Gum trees - 2 on Mt. Laurel Ave. to the east of the Chapel on the "Church Plot", 2 on the curve of Woodland Ave. after Trinity intersects, 1 on corner of Valley Rd. and Woodland and 1 slightly up from it on Valley Road, close to the 16th Street entrance. Nos. 133, 134, 135, and 136.

Planted 1 Copper Beach on west side of Baber Ave. close to where Pott White Oak was cut. No. 122.

Planted 1 Kentucky Coffee Tree on east side of Baber Ave. in plot between Mt. Laurel and Trinity Ave. No. 121

Planted 1 Ginkgo midway down the hill between Trinity Ave. & Mt. Laurel Ave. by section 4. No. 126.

Planted 1 Kousa Dogwood to replace last year's dogwood on south side of Mt. Laurel Ave. sec. A\B.

2015 - Planted 4 Pin Oaks - 1 close to 16th St. entrance on south side of Valley Road (Mt. Laurel Ave.) in sec. 3, 2 across from each other, one east side and west side of Woodland Ave. loop closer to Valley Road intersection and 1 on north side of Trinity Avenue sec. MM. Nos. 133, 134, 135, and 136.

Planted 1 Weeping Cherry on East Mt. Laurel Ave., northern side in sections I. No. 129.

Planted 1 Horse Chestnut on East Mt. Laurel Ave., northern side in sections T. No. 131.

Planted 1 Copper Beech on East Mt. Laurel Ave., southern side in sections D. No. 130.

Planted 1 Swamp White Oak in eastern Church Plot, 1/2 way down from grassy path. No. 128.

Planted 1 London Plane on north side of Trinity Ave. on east side of section EE. No. 132.

Planted 1 Ginkgo in western Church Plot, east side, near to grassy path. No. 127.

Replaced 1 Black Gum on East Mt. Laurel Ave. close to chapel on West Church Plot.

2016 - Planted 5 Swamp White Oak - 2 north of pond on south side of Valley Road and 3 south of pond on north side of Elm Ave. Nos. 140, 141, 142, 145. One swamp oak not sponsored.

Planted 2 Kanzan Cherry - 2 on east side of pond on grassy path known as East Lake Drive (Lake Path). Nos. 143 and 144.

Planted 2 Japanese Maple - 1 on south side of Mt. Laurel Ave at intersection to Elm Ave and West Lake Drive - no. 139, and 1 on southern side of Mt. Laurel Ave., east of chapel, close to where section B meets section D - no. 138.

Planted 1 Pin Oak inside 16th St. entrance on south side of Valley Road in section 2, No. 146.

- 2017** - Planted 3 Red Buds on and beside the rock wall built at the 16th St. entrance. Nos. 147, 148, 149.
Planted 3 Flowering Dogwood (gifted by Pine Creek Landscaping), one in Sec. 6 west of the pond, one in Sec. 16 east of the pond, and one in Sec. D east of the main entrance. Nos. 151, 153, and 156.
Planted 2 Bald Cypress (purchased by Joe Orlowsky) southern side of the pond basin. Nos. 154 – 155.
Planted 1 Pin Oak on Trinity Ave. by Wachter's property line up from the Woodland Ave. loop . No.150, and 1 pin oak not sponsored in 2016 in northern side of pond area. No. 152.
- 2018** - Planted 4 Red Buds to the east of the 16th Street entrance and the rock wall inside the entrance. Nos. 157, 158, 159, and 190.
Replaced the 3 Flowering Dogwoods that died last year.
In lieu of planting 6 additional new trees, 6 existing European Hornbeams on the east side of east gatehouse on Market Street were sponsored. Nos. 161, 162, 163, 164, 165m and 166.
- 2019** - Planted 4 Pin Oaks on the north side directly inside the 16th Street entrance. Nos. 167, 168, 169, 170.
Planted 2 Little Leaf Linden-both in Section 6, 1 across from the pond where one fell, and 1 on the north of Sec. 6 by the barn. Nos. 171 and 172.
Planted 4 Eastern Red Cedar - 1 by McBarron Alley where one had died last year, 3 by the neighbor's fence to the north of the last eastern cedar plantings. Nos. 173, 174, 174, and one rededicated.

Planted 1 Tuliptree (Brown) no. 185 southern side of Section GG
Planted 1 Red Oak (Kauffman) no. 177 southwest side of Section 19 near Maplewood loop
Planted 1 Weeping Willow-special order (Goodwin) Middle of Section 19
Planted 5 Redbud (Kovalovich & Wilk)nos. 183 & 184, 2-eastern side of Section 4 near obelisk; (Artz, Kovich, Speacht) nos, 186, 187, 188, 3-in a row on path between Sections A and H
Planted 3 Bald Cypress (Kerrigan) no 182, southwest corner of pond; (McCloskey) no. 180, northeast corner of pond; (Harrison) no. 181, southern quadrant edge of pond

2021 Fall – Planted 1 Kwanza Cherry (Field/Moser) no. 191, northeast side of East Pond Road
Planted 1 Blue Spruce (Yuengling) no. 190, northwest side of Eastern Church plot by Chapel Ave.
Planted 1 Norway Spruce (Warner) no. 189, northeast side of Eastern Church plot by Chapel Ave.
Planted 1 Redbud (Brown) no. 192, southeast corner of Section C

2022 - Planted 3 Sugar Maples - All 3 trees are on White Rose Lane north of Comloquoy mausoleum between Section 15 and 16. One Sec. 15 midway (Moser) no. 201, 1st corner of Rose & Valley Road, Sec. 15 (Sullivan) no. 200, 1 in sec. 16, down from corner of Rose and Valley (Brown) no. 202.
Planted 5 'Autumn Radiance' Red Maples -Four on Chapel Ave planted on Terrace Section, east of chapel. First one closest to chapel (DAR) no. 193, 2nd one Artz, III no. 194, J. McCloskey no. 195., 4th Armstrong no. 196. Fifth tree on southeast corner of first Church Plot nearest chapel near Mt.Laurel Ave. (Not sponsored)
Planted 1 Japanese Cryptomeria in front section of Huntzinger plot, Sec. P (Frantz) no. 197.
Planted 1 Japanese Red Maple-corner of Baber and Trinity Aves. on sec. AA (Zane) no. 198.
Planted 1 Tuliptree -One-third eastern part of section 4 near Mt. Laurel Ave. (Field) no. 199. Red bud trees of Kovalovich and Artz sponsored 2021 replaced and blessed.

2023 - Planted 2 Japanese Maples: One in Sec. W closest to stone wall (Murphy) #203; 2nd in Sec. 14 closest to barn (Artz & Stralkus) #213.

Planted 3 Red Oaks: One near path on southeast corner of Sec. F (Marsicano) #204; 2nd near Hillcrest Ave. and chapel in Sec. SS, (Ida Lee H. Elliott for Robert K. Elliott) #206; 3rd midway on hillside of Sec. SS (Fred & Dona Brown) #207.

Planted 3 Sugar Maples: One slightly in from the beginning of east loop of Maplewood Ave. (Ida Lee H. Elliott for Ed & Carrie Messersmith) #208; 2nd neat northeast corner of Maplewood Ave. (Joe and Nancy Schlitzer) #209; 3rd 1\3rd in on norther top of Maplewood Ave. (Brian Scheib) #210.

Planted 2 'Greenspire' Little Leaf Linden: One on northeast part of Sec. 6 (Joanne McCloskey) #211; 2nd on northwest of Sec. 6 (Peter and Patti Armstrong) #212

Planted 3 Red Buds: Along neighbor's fence line of Sec. 14 northern part closer to barn (Todd Thompson) #214; 2nd tree in from Thompson rosebud east side of northern top of Sec. 14 (The Rev. Canon Clifford B. Carr) #215; 3rd in is third rosebud tree in from barn on east side of northern top of Sec. 14, (3 Ida Lee H. Elliott for Luke & Helen M. Heinbach) #216.

2024 - Planted 4 Red Oaks: Three on Valley road in front of the storage barn (Patti and Peter Armstrong #218; Joanne McCloskey #219); and (Andrew Matta #224). The 4th is at the corner of Section 2 where it meets Section 1 off Trinity Avenue in front of Wachter's fence (Irvil Kear #221).

Planted 4 Japanese Ivory Silk Lilacs: Three on the northwest side of section 2 at top of the wall along Trinity Avenue (Howard Mitchell #223; Anthony Marasco #222; Fred Brown #220). The 4th is on the east side of the storage barn (Frank Murphy #217).

Planted 1 Ginkgo: South side and middle of Section 2 near Wachter's fence (Sue York #225).

2025 - Planted 2 Arborvitae: Lower middle part of Section 18 at bottom of row of mature arborvitae #226 by Frank and Annie Murphy (north side) and #227 by Sandy Mirabella (south side).

Planted 2 Japanese Maple: (1) In section 20 north west corner #228 (Debra Zyk and Family) and (2) in Sec. 6 near Maple Ave. #230 (Andy & Erica Matta).

Planted 2 Weeping Cherry: (1) In pond area #229 by Peggy Moser; (2) In Sec. 2 near 16th St. #233 by Fred Brown.

Planted 2 Red Bud in Section 14 along fence line: (1) #231 east side by Joseph & Leigh Ann Siminitus; (2) west side #232 by Arthur and Elizabeth Marsicano.

Planted 1 Red Oak in Section Q #234 by Hermine and Danny Murphy.

Replaced dead red oak in space between Section Q and F by Arthur and Elizabeth Marsicano.

2026 - Planted 7 Red Bud on northwest side of pond starting at meditation area (1) #239 by Elizabeth Boyer & Family; (2) #240 by F. Allen Artz and George P. Planted 2 London Planetrees side by side in Section 1 along top of stone wall closer to Wachter's garage (1) #235 - by the Estate of Peggy Moser; (2) #243 by Fred Brown;

Planted 1 Weeping Willow on northwest side of pond #242 by Frank and Annie Murphy.

Planted 1 Weeping Cherry in Section 1 on top of stone inner wall near 2nd set of steps
#236 by Kathryn Polcrack.

Planted 1 Japanese White Lilac in Section 1, close to inner wall and wachters garage #236
by The Charles Baber Cemetery
